



Virtual program


This special award is to recognize Mara Ginsberg who through her personal experience saw the need for To Life! and works diligently to continue the mission to benefit the survivor community and their families.

### **The Vision**



Mara Ginsberg is a breast cancer survivor, one of thousands of women in our community who call themselves survivors/thrivers. As a wife and young mother of two, Mara was diagnosed with breast cancer at the age of 37. Unlike many others who are quite

surprised by this diagnosis, Mara was prepared, having lost her mother and aunt to the disease, both at a young age. But that didn't make it any easier to navigate. She was dismayed at the lack of information about treatment options, information and support were at best hard to find or simply not available. Mara sought and received good medical treatment. She had a loving family who stood by her side, provided love and care. But she needed more. Her experience was all too familiar; emotionally overwhelmed, weakened by the treatments, isolated by a disease that can be uncomfortable to talk about, Mara's questions: how do other women do this? How do those women cope? Turning these questions over and over, the answers started to crystallize. Gather



women together, foster support and information sharing, having a good laugh.

The organization would provide one-on-one and group support, include informative, educational programs, forums for local medical experts to share knowledge. Mara wanted women to feel beautiful during and after treatment. Boutiques that offered wigs, hats, mastectomy bras and prosthesis can help women regain control of their physical appearance. Mara Ginsberg, a two time breast cancer survivor herself experienced a significant gap in information about breast cancer, treatment options, and emotional support here in the Greater Capital Region. Her vision, to provide information, support and services for those dealing with breast cancer, was visionary. To Life! formed as these really good ideas became something more; became solid goals, found friends who supported such goals, developed into a plan, became real. In 1998, Mara started To Life! with \$72 in the bank and a good vision. Mara planted the seed to build a community committed to making the very best of the breast cancer journey. A foundation upon which to foster the network, the connections. To Life! continues to thrive, expanding on Mara's vision and holding true to the values she promoted from the very start.

Mara continues to serve the organization as Founder of To Life!, President Emeritus, Chair of Education and Scientific Advisory Committee.

August 11 Beat The Odds "Breast Cancer Immunotherapy: Past, Present and Future" Dr. Margaret Gatti-Mays, MD, MPH (2021 Cynthia Shenker Speaker)

To Life! was pleased to host Dr. Margaret Gatti-Mays for the August symposium Beat the Odds. This summer program is well known and well respected, covering new developments with leading experts in the field of breast cancer. Dr. Gatti-Mays, Oncologist with the James Comprehensive Cancer Center at The Ohio State University is one of the leading authorities in the field of immunotherapy for Breast Cancer treatment.

### **November - January**

Entering our 11th year, the Women's Health Conference Series offers the latest information regarding treatments and trends in breast cancer and related health issues. Starting in November, a series of four individual virtual sessions included a formal presentation followed by a Q & A session. Topics covered; fear of recurrence, managing psychological trauma, nutrition during treatment, and integrative therapies. Capitalizing on the virtual presentation, we took the opportunity to bring in speakers from some of the major cancer centers. With each presentation, the speaker had a solid command of the material and was able to interject current and fresh strategies. **November 9, 2021 Breast Cancer** Recurrence: Managing the Fear & Living Your Life

Two-time breast cancer survivor, Lillie Shockney, RN., BS, MAS, ONN-CG, spoke on the topics of fear and anxiety around breast cancer recurrence, coping with that fear so it doesn't paralyze survivors from living their lives. Lillian was an engaging storyteller and emphasized quality of life as a priority. Lillie Shockney was the former Director of the Johns Hopkins Breast Center, Baltimore, Maryland.



### November 17, 2021 **Psychological** Trauma and **Breast Cancer** Cheryl Hysjulien, RN,

PsyD presented on the stress and trauma of a breast cancer diagnosis, the sympathetic nervous system response, and about post-traumatic growth, and mind-body tools for mitigating stress and trauma around a breast cancer diagnosis and treatment. Dr. Hysjulien is a registered nurse and licensed clinical psychologist at the Sanford Roger Maris Cancer Center, in North Dakota, specializing in health psychology with further specialization in psycho-oncology.



### **December 8, 2021** Nutrition for **Breast Cancer** Patients and Survivors

Oncology Nutritionist, Julie Bosworth, RD, LDN, presented on practical and scientifically-sound nutrition for breast cancer patients and survivors. Having been diagnosed with breast cancer, at age 41, Ms. Bosworth will speak from the perspective of nutrition expert, as well as breast cancer patient and survivor. Julie Bosworth, RD, LDN, is an oncology nutritionist, registered and licensed dietitian, and Senior Dietitian at Dana Farber Cancer Institute with special training and skill in assessing, diagnosing, and treating dietary and nutritional problems.



### January 13, 2022 Integrative Therapies in **Breast Cancer** Care

Ting Bao, MD, DABMA, MS, spoke on the role of integrative therapies, in complementing more conventional breast cancer care and mitigating the side effects of breast cancer treatment and the use of aromatase inhibitors, to meet treatment goals and maintain the best quality of life possible. Ting Bao, MD, DABMA, MS, is an Integrative Medicine Specialist and the Director of Integrative Breast Oncology at Memorial Sloan Kettering.
